February Board Minutes

February 10, 2003. Ann Ferrill called the meeting to order. The attendees were Jo Blanchard, Mike Compton, Don Gattinger, Dick Heil, Margaret Kelly, Leah Lasley, Rick Lowens, Bobby Morgan, Lou Morris, and Diane Tait.

The minutes of the last meeting (held in January) were read, approved, and seconded.

A formal treasurer's report was not provided for this meeting.

OLD BUSINESS:

It was reported the Club Series is going well with 21 participants. Since this class is scheduled to end soon, Dick Heil will make a recommendation for the format and financial arrangements of the next class.

NEW BUSINESS:

Cup holders were recently added to some of the playing tables. Ann will look into the cost for adding them to all of the tables.

The Board was notified the Club must begin paying for the printing cost of the *Newsletters*. The cost to print the February *Newsletter* was approximately \$40. The board encourages all members with e-mail access to provide their e-mail addresses so the club can distribute *Newsletters* electronically to as many members as possible. This will save the Club printing fees and in some cases, postage fees.

Our insurance policy will lapse on May 23 and it will not be up for renewal. The current carrier no longer handles this type of policy. Mike Compton will contact other agents to obtain replacement quotes.

The lease on the Bridge House is up the end of April and the rental cost per square foot is scheduled to increase. The owner indicated if the club wants to make

improvements to the building it would split the cost 50/50 with the club. It was also reported that the dance studio next door wants to incorporate a portion of the Bridge House's space into its area. Discussion included: What square footage is necessary to accommodate playing needs and how could we remodel to make do with less square footage? What are remodeling possibilities for the kitchen, bathroom, and storage areas? What about moving the heating/cooling units to the roof? If the divider wall can be removed and is removed, what are ways to make separate areas so multiple events can be accommodated at the same time? A committee was appointed to consider the lease and remodeling possibilities and submit proposals and designs back to the board. The committee includes Mike Compton, Dick Heil, Margaret Kelly, and Rick Lowens. Other club members will be asked to join who have expertise in needed areas.

It was also recommended that lighting for the south-side parking lot and an outdoor water spigot be requested when the lease is negotiated.

The board was notified there is a need for members to volunteer to be available as an extra when a partner is needed or to make a half table complete. The board will ask for a club member to act as a "Partnership Chairman" to organize a group of volunteers to be available on a routine basis as an extra. A King Cake was provided for today's monthly birthday celebration. Whoever gets the "baby" in their piece of the King Cake will be responsible for providing the birthday cake for March.

Opening One No-trump

David Siebert

There are 3 ways to approach opening no-trump with a 5-card major:

1. Never open a NT with a 5-card major.
2. Never open a NT with 5 ♠s.
3. Open everything a NT with any 5-card major and a square hand (5–3–3–2).

Many of the top partnerships go with #3 (open everything a NT). This is also my philosophy.

Hands are easier to describe. The only disadvantage is missing your 5–3 major fits—which you will not miss at

game level if you use Puppet Stayman, which I have already discussed in the July 2002 issue of the *Newsletter*.

A big advantage to opening 1NT is that the opponents have a harder time getting into the auction.

Witness this hand played in the Women's World Championship last year:

Misdefense allowed them to make 4♠. However note with 1♠ opening bid West would bid 2♣. North bids 4♠ and East 5♣, making 5. This hand helped win the World Women's Pairs for Karen McCallum and Debbie Rosenberg.

Keeping the opponents out of the action is one of the big advantages of opening 1NT with any 15–17 HCP hand and a 5-card major. I have had excellent results doing this. Try it and I think you will like your results, too! Have a good month. ♠

When to Bid

AI Childs

Do you overcall or double on anything or do you wait and balance. I try to teach my partners that a simple overcall is an opening bid or lead directing.

Kathy and I had this hand on OK Bridge and she bid it well.

West opened 1♥ and with 5♥s and 4-4 in the minors she passed. East bid 1♠. ♠s are too good and 7 makes it too strong for a weak jump. I thought about bidding 2♦, but ruled it out because suit and hand were not strong enough. And I had an honor in other suits.

When Kathy doubled 2♠ in the pass-out seat I knew I could compete to 4♦. She added values for her void and bid 5♦.

The play is tricky. Because of the NT rebid and double I played ♦s to be 2-2 and made 6.

AI Childs

Sometimes when you cash tricks in the right order and give count a trick may be created.

Kathy lead ♣Q, ♣K, ♣A.

I returned ♦2 showing an honor; Kathy won ♦A and returned ♦3 showing 2 or 4. With the fall of ♦Q-J, I returned ♣5 showing 3; she won ♣J and led another ♣. She now counted declarer with 6 ♠s, 2 ♦s, 3 ♣s, and 2 ♥s, one if it's a loser can be discarded on a ♦. Declarer now led ♠10 which I did not cover. He rose with ♠K which Kathy won and lead the thirteenth ♣, which I trumped with ♠J setting up her ♠8. Playing her for the ♠A could be right.

Defense Is Fun

Here is a hand from the club that I enjoyed because both defenders were able to score ruffs in the same suit. I was sitting West and Alex Phillips, our newest (and youngest ever) life master, was East.

Opening Lead: ♥K

Declarer grabbed the opening lead with dummy's ♥A, then ditched one of her ♥ losers on the ♠A.

Because of the blockage in ♦s, declarer need to set up that suit before she could tackle trumps, so she played a diamond to her ♦Q, which I won with the ♦A.

When I cashed my ♥Q, Alex discarded the ♦J! So I led my other ♦, which he trumped.

Now Alex got out with a low ♠, which declarer won in her hand with the ♠9. When she led another ♦, I trumped it with my last ♠, then played another top ♥, forcing declarer to ruff in her hand, Alex discarding a ♣.

Now she trumped another ♦ with the board's ♠K, and Alex made a very good play by refusing to over-ruff (if he plays the ♠A, she makes her contract). Declarer trumped a ♣ back to her hand and now was in desperate straits with only one trump left in each hand. When she led a ♦ and pitched a ♣ from the board, Alex ruffed with his little ♠, pulled the rest of the trumps with his ♠A and took the last trick with his ♣K for down two.

Well done, Luke Skywalker! ♦
