### Bidding Against Weak No Trump

**David Siebert**

I have had a lot of questions on how do you defend (meaning bid) over a weak NT.

The system I have is pretty effective.

First I use Reverse Hamilton over strong & weak NT as far as my overalls go.

1. Double shows NT—approximately 14–18 high card points (you have to shade a little on both sides, thus 14–18 rather than 15–17).
2. 2♣ shows a one-suited minor, such as:

K	x	K	x

or a major and a minor, such as:

You must bid 2♦ over 2♣ and if partner passes she has ♦s. If she bids 2♥ she has ♥s and a minor. If you don't like ♥s you bid 2NT to ask which minor. Same if partner bids 2♠. If partner bids 3♣ she has a one-suited hand in ♣s.

3. 2♦ shows both majors.
4. 2♥ = ♥s.
5. 2♠ = ♠s.

6. 2NT shows both minors.

7. Double by a passed hand shows ♣s, but the rest of the system described above is on by a passed hand.

Over a regular NT if partner doubles and you want to pull just bid your suit.

Over a weak NT play systems ON.

After double example:

Bidding: 1NT (weak; by Opp)—X (by your partner)—Pass (by Opp)—2♥ (transfer; by you). This might be your hand:

Another after double example:

Bidding: 1NT (weak; by Opp)—X (by your partner)—Pass (by Opp)—?

Opps Vul. & you N.V.—You would pass.

You Vul. & Opps N.V.—Bid 2♣ (Stayman).

Vul. vs Vul. or N.V. vs N.V.—your choice (you better be right).

Also another effective weapon is:

Bidding: 1NT (weak; by Opp)—Pass (by your partner)—2♣ (Stayman; by Opp)—Double by you shows a good hand just like the double over the weak 1NT immediately in the example above.

For example, you hold:

K	K	K	A
Q	Q	x	x
x	x		x
x			x

You double. The only forcing bid by partner is 3♣. In response, you start bidding 4-card suits up the line. Any jump by partner over the 2♣ doubled is invitational and a 2-level by partner bid is drop dead.

The important part of this lesson is over a weak NT and a double systems are ON and over a weak NT—pass—2♣—double shows a good hand, NOT a double of ♣s.

Try this with your favorite partner. ♦

## New Wednesday Day Game

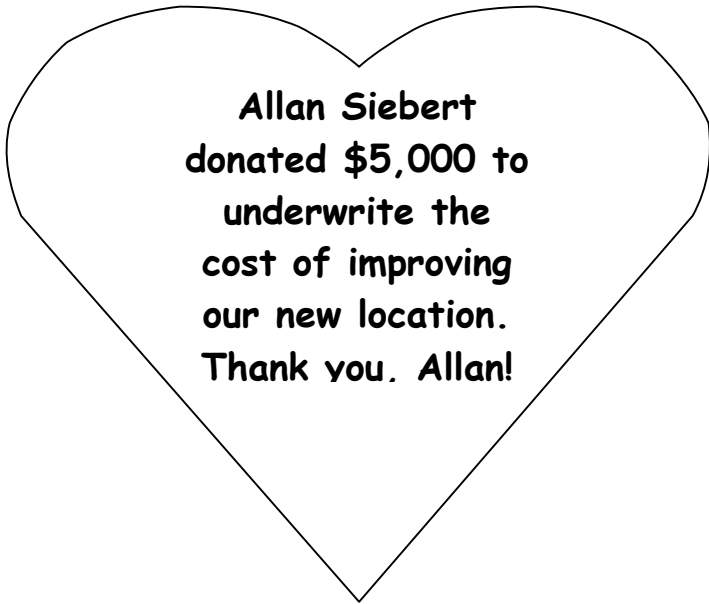
The new Wednesday daytime game is a big success — at the inaugural game there were seven full tables, 12 new Bridge House members, and new members with masterpoints. The winners were:
