### To Overcall or Not to Overcall?

This hand from a pairs game at the Little Rock Memorial Day Tournament illustrates the difference between pairs vs. team-game strategy and the danger of overcalling anemic suits when vulnerable.

With N-S vulnerable and E-W not, East (my partner Gerald Koonce) opened 1♠ in third seat and South overcalled 2♦. I held a void in ♠s, ♥ A 4 3, ♦ J 9 7 3, and ♣ J 10 7 5 4 2—a lovely hand opposite my partner's opening ♠ bid. (Partners always bid your voids.) I passed, dreading what was coming: either I would hear a reopening double, or—even worse—more ♠s at exalted levels.

North passed and East, as expected, reopened with a double. Atimps, I might have bid 3♣ because my hand was so weak and I did have a playable suit. (They might wrap 2♦ doubled for minus 180 or 380 opposite the possible plus 50 or minus 110 our team-mates would bring back for 3♣ either making or going down a trick at the other table.) If South's suit had been a

major, in a team game the odds would favor bidding 3♣ even more, since minus 670 opposite plus 50 or minus 110 could cost the match. At pairs, however, I chose to chance going for plus 200 and I passed.

Here are all four hands:

With a void, one can't even lead through the dummy to partner's bid suit. Hoping my partner wasn't long in ♣s, I led my ♣J. When the dummy went down, it looked as if we might actually defeat this contract! In fact, it turned out there was no way South could make his bid opposite any minimum defense—all lines go down.

North took my ♣J with his ♣A, East playing the ♣K. (A duck might be a better play, but on this hand it wouldn't matter.) North then led low to the ♥Q, Gerald signaling an even number, and I took the trick with the ♥A. I led to Gerald's ♣Q and discarded my ♥s on his high ♠s. Gerald led another ♠ for me to ruff, and I returned a ♣, which he ruffed with the ♦Q, declarer over-ruffing with the ♦A. We were still due a ♦ trick, so declarer was

down one for minus 200. We tied for top on the board, so another South in our section must have made the same overcall.

South had committed two cardinal bridge sins when he overcalled at the 2-level: first, he was vulnerable and his bid suit was weak (only 5 cards with 1½ honors and a K Q in a short suit). Second, he had length in the opponent's suit, a dangerous situation because the opponents, with no fit, were much more likely to double.

If South had not overcalled, we would not have been in a wonderful situation. If I were to pass (I wouldn't), we would be in 1♠ and West would get only one trick from my hand. If I were to bid a semi-forcing 1NT, West might pass or bid 2♥, and I would leave him there—yuck. South had challenged the gods of bridge probabilities and lost. Walking on the wild side is safer when you're armed in a stout suit. ♠

The minutes of the last meeting were read, amended, approved, and seconded.

A treasurer's report was not provided for this meeting.

### OLD BUSINESS:

The new Wednesday morning bridge session is reported to be going well with pretty good attendance and has resulted in 21 new memberships. Mailboxes will be setup for the new members. STaC games are scheduled for the week of December 8 – 14. The STaC games previously scheduled in October were cancelled.

She raised a concern to the Board that we might not have enough space at our present location and offered the following solutions: rent a larger space for the party, hold 2 separate parties, or take reservations for a single party to be held at the club. The options were discussed and will be explored further.

When you notice an error on a traveler, please do not circle the error and pass the board on. It then becomes a problem when everyone is ready to go home or might already be gone. Take the traveler to the person who has scored it incorrectly and have them correct the score at the time the error is noticed. The playing director may have not played that hand yet. When you notice the error, you are the best person to find out what really happened. To leave the incorrect score to be corrected at the end of the game will just delay the final results from being published. Do not assume you know what the correct score is either. Take it to the person who scored it. Just another one of the ways to make the games run more smoothly. ♠
